

ORDINANCE 01-110.1

**AN ORDINANCE ESTABLISHING THE BOUNDARIES
OF MAGISTERIAL/JUSTICES OF THE PEACE DISTRICTS**

WHEREAS, pursuant to KRS 67.045, the County is required to redistrict in accordance with current census information; and,

WHEREAS, the total population of McLean County as listed in the 2000 Census is 9,938, and

WHEREAS, in order to achieve the division of McLean County into compact, contiguous, and equal in population as reasonably possible, the number of magisterial districts shall remain four(4), with changes only to the boundaries of the Northeastern and Southeastern districts.

NOW THEREFORE, BE IT ORDAINED that the four(4) magisterial districts of McLean County shall have the following boundaries:



2001 REAPPORTIONMENT - FOUR(4) MAGISTERIAL DISTRICTS

BOUNDARIES

SOUTHWEST DISTRICT - Beginning Green River at mouth of Pond River, thence east up Green River to Carter-Revlett ditch, thence with west side of said ditch south across KY HWY 138 to Intersection of Stroud Levy Road, thence with west side of Stroud Levy Road to Cypress Creek, thence with west side of said creek to the Muhlenberg County line to point of beginning. (No change)

SOUTHEAST DISTRICT - Beginning south side of KY Hwy 136 at junction with the Ohio County line, thence with the southern boundary of the Northeast District to Green River, thence up said river to the eastern boundaries of the Southwest District, thence with said boundary to the Muhlenberg County Line to Green River, thence down said river to point Rough River joins Green River, thence along said Rough River to the Ohio County line, thence with the Ohio County line to point of beginning.

NORTHEAST DISTRICT - Beginning at the Daviess County line at its junction with the Ohio County line, thence west along the Daviess County line to the boundary of the Northwest district at KY Hwy 81, thence south with the east side of KY Hwy 81 to Green River, thence along Green River to Buck Creek West Fork, thence along north side of drainage ditch of Buck Creek West Fork, thence with north side of the abandoned Schnieder-Tanner Road to Brown Road, thence with Brown Road to Hicks Road, thence with Hicks Road to its intersection with Richland Road, thence along north side of Richland Road to Ky Hwy 136, thence along north side of Ky Hwy 136 to US 431, thence west side of US Hwy 431 north to KY Hwy 1080, thence east with north side of KY Hwy 1080 to intersection with KY Hwy 136 at the Ohio County line, thence north along the Ohio County line to the point of beginning.

NORTHWEST DISTRICT - Beginning Green River at the Daviess County Line, thence east with the Daviess County line to the westside of Ky 81, thence South with KY Hwy 81 to Green River to the point of beginning.(No change)
